**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of October 5, 2023 (this "Release"), is made by **MANUFACTURERS AND TRADERS TRUST COMPANY**, as administrative agent (in such capacity and together with its successors and permitted assigns, the "Administrative Agent") in favor of **CLARK CORE SERVICES, LLC**, a Pennsylvania limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of April 26, 2023 and recorded in the United States Patent and Trademark Office on May 5, 2023 at Reel/Frame **008062/0793** (the "Trademark Security Agreement"), made by the Grantor in favor of the Administrative Agent, the Grantor granted to the Administrative Agent, among other things, a continuing security interest in, all of its right, title and interest in and to the certain trademark identified on **Schedule A** hereto and incorporated herein by reference (the "Specified Trademark");

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in **only** such Specified Trademark;


NOW, THEREFORE, good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges its lien on and security interest in, all right, title and interest in and to the Specified Trademark and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified Trademark.
2. The Administrative Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office to evidence the partial termination and release granted by this Release.
3. Nothing contained herein shall constitute a release or reassignment of the security interests or interests in any other trademarks and other property assigned by way of security by the Grantor pursuant to the Trademark Security Agreement.
4. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
