**Release of Second Lien Security Interest in Intellectual Property**

This Release of Second Lien Security Interest in Intellectual Property, dated as of October 2, 2023 (the “Release”), is made by GOLDMAN SACHS BANK USA, as collateral agent (in such capacity, the “Agent”) in favor of DR JOHN’S LABS, LLC, a Wyoming Limited Liability Company (the “Grantor”).

WHEREAS, by (i) that certain Second Lien Guarantee and Collateral Agreement, dated as of March 20, 2018, by and among the Grantors, the other grantors party thereto and the Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Second Lien Intellectual Property Security Agreement, dated as of June 12, 2019, in favor of Agent (as amended, restated, or modified from time to time, the “IP Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement, as applicable), which IP Security Agreement was recorded with the United States Patent and Trademark Office on May 22, 2020 at Reel 52734, Frame 303 (patents) and Reel 6945, Frame 0045 (trademarks), Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement), including those patents and trademarks listed on Schedule I hereto;

WHEREAS, Grantor desires Agent to release, discharge, terminate and cancel its lien on and security interest in the Intellectual Property Collateral, including, without limitation, the patents and trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Intellectual Property Collateral and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Intellectual Property Collateral.

The Agent authorizes and requests that the Commissioner for Patents, Commissioner for Trademarks, and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
