**RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS (FIRST LIEN)**

This **RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS (FIRST LIEN)** (this “**Release**”) is made as of October 6, 2023 by BANK OF MONTREAL, as the Collateral Agent (in such capacity, the “**Collateral Agent**”), in favor of DOSKOCIL MANUFACTURING COMPANY, INC. (“**Doskocil Grantor**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreements (defined below), or if not defined therein, in the Security Agreement (defined below).

**WHEREAS**, Doskocil Grantor is a party to that certain (i) First Lien Term Loan Security Agreement, dated as of September 15, 2021 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) by and among Doskocil Grantor, the other Grantors (as defined therein) and the Collateral Agent, and (ii) First Lien Term Loan Trademark Security Agreement, dated as of September 15, 2021, by Doskocil Grantor in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 7423, Frame 0812 on September 16, 2021, and First Lien Term Loan Trademark Security Agreement, dated as of October 25, 2021, in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office at Reel 7471, Frame 0618 on October 25, 2021 (collectively, the “**Trademark Security Agreements**”);

**WHEREAS**, pursuant to the Security Agreement and the Trademark Security Agreements, Doskocil Grantor pledged and granted to the Collateral Agent a lien on and security interest in all of Doskocil Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on **Schedule A** hereto;

**WHEREAS**, the Collateral Agent received an Officer’s Certificate of Astro One Acquisition Corporation, a Delaware corporation dated as of October 6, 2023 (the “**Officer’s Certificate**”);

**WHEREAS**, Doskocil Grantor has transferred ownership of the Trademarks set forth on **Schedule A** hereto (the “**Specified Trademarks**”), to Pluto Opco (Cayman), LLC pursuant to an Intellectual Property Assignment Agreement, dated as of October 6, 2023,

**WHEREAS**, Doskocil Grantor has requested that the Collateral Agent terminate, release, relinquish and discharge fully its lien on and security interest in all right, title and interest of Doskocil Grantor in and to the Specified Trademarks, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its lien on and security interests in the Collateral as herein provided.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, and without recourse to it, in reliance on the Officer’s Certificate hereby terminates, releases, relinquishes and discharges the lien on and security interest in and to the Specified Trademarks granted to it under Security Agreement and the Trademark Security Agreements, and assigns and re-assigns to Doskocil Grantor any and all right, title or interest it may have under the Security Agreement and the Trademark Security Agreements in such Specified Trademarks. For the avoidance of doubt, the Collateral Agent retains, and does not hereby terminate, release, relinquish, discharge, assign or re-assign to Doskocil Grantor, its valid and continuing security interest in any rights, title or interest retained by Doskocil Grantor, including any rights, title or interest, in, to and under that certain Intellectual Property License Agreement, dated as of October 6, 2023, pursuant to which Pluto Opco (Cayman), LLC granted to Doskocil Grantor a license to the Specified Trademarks.

Furthermore, for the avoidance of doubt, this Release is applicable only and solely with respect to the Specified Trademarks and to no other collateral arising under the Security Agreement or the Trademark Security Agreements. The Collateral Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Collateral Agent under the Security Agreement and the Trademark Security Agreements with respect to all such other collateral, and the Collateral Agent's security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.
