**RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY RIGHTS**

This **RELEASE OF GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS** (the “*Release Agreement*”), is dated as of October 03, 2023, by BANK OF AMERICA, N.A., a national banking association, as Administrative Agent (in such capacity, the “*Administrative Agent*”) for the Secured Parties (as defined in the Credit Agreement).

WHEREAS, Mattel, Inc., a Delaware corporation (the “*Grantor*”), executed and delivered that certain (a) Patent Security Agreement, dated as of September 15, 2022 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Patent Security Agreement*”) and (b) Trademark Security Agreement, dated as of September 15, 2022 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Trademark Security Agreement*”, and together with the Patent Security Agreement, the “*Security Agreements*”), granting the Administrative Agent a security interest in and lien on certain patents, patent applications, trademarks, and trademark applications (collectively, “*Collateral*”) described therein, which includes the Collateral listed on Schedule A hereto, which was recorded with the United States Patent and Trademark Office (“*Office*”) on September 16, 2022, at Reel 061451, Frame 0850, and the Collateral listed on Schedule B hereto, which was recorded with the Office on September 16, 2022, at Reel 7848, Frame 0431.


WHEREAS, the Grantor has requested that the Administrative Agent release, discharge and terminate all liens and security interests granted to the Administrative Agent under the Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (a) releases the Grantor from the Security Agreements, (b) releases, terminates and discharges all liens and security interests and all right, title and interest in, to and under the Collateral, and (c) authorizes and requests that this Release Agreement be recorded at the Office.
