RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of October ____10____, 2023 by CITIZENS BANK, NATIONAL ASSOCIATION ("Bank") to NWHW HOLDINGS, INC., a Delaware corporation, NEW HORIZONS WORLDWIDE, INC., a Delaware corporation, NEW HORIZONS EDUCATION CORPORATION, a Delaware corporation, NEW HORIZONS FRANCHISING GROUP, INC., a Delaware corporation, NEW HORIZONS COMPUTER LEARNING CENTERS, INC., a California corporation, and NEW HORIZONS COMPUTER LEARNING CENTER OF PORTLAND, INC., a California corporation (collectively, the "Grantor").

WHEREAS, Bank and Grantor entered into that certain Intellectual Property Security Agreement dated as of August 17, 2016 (as amended, supplemented, or otherwise modified from time to time, the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, Grantor granted to Bank, a security interest in all of right, title and interest in, to and under certain intellectual property identified as Intellectual Property Collateral and listed in the Security Agreement, including those items set forth on Exhibit A; and

WHEREAS, the security interest was recorded with the United States Patent and Trademark Office on August 17, 2016 at Reel/Frame 5857/0467.

WHEREAS, Grantor has paid all of its outstanding indebtedness to Bank.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby (i) terminates the Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral, including all goodwill thereto, and (iii) re-assigns to Grantor any right, title and interest it may have in, to or under the Intellectual Property Collateral, including, without limitation, any goodwill associated therewith, to Grantor.

Bank shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of Delaware and applicable federal law.


