RELEASE OF TRADEMARK SECURITY AGREEMENT

October 6, 2023

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of June 9, 2021, recorded in the United States Patent and Trademark Office at Reel 7325, Frame 0399 on June 14, 2021 (the “Trademark Security Agreement”), LIFECORE FITNESS, LLC, a Delaware limited liability company (formerly known as LIFECORE FITNESS, INC., a California corporation) (“Releasee”), created in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION (“Releasor”), a security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.


Release of Security Interest. Releasor hereby (i) terminates, releases, relinquishes and discharges its security interest in the Trademark Collateral, including without limitation, all of Releasee’s right, title and interest in and to the Trademarks listed on Schedule 1 hereto, and (ii) reassigns, transfers and conveys to Releasee any right, title and interest of the Releasor in the Trademark Collateral, in each case, without recourse or representation or warranty, express or implied, of any kind.

Authorization. Releasor hereby authorizes Releasee or Releasee’s agent to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.
