Assignor authorizes the Commissioner of Trademark of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the Marks to Assignee as assignee of Assignor's entire right, title, and interest therein; and Assignor hereby agrees to execute such further documents as Assignee may deem necessary to perfect and/or record the transfer of rights to Assignee.

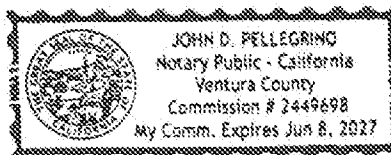

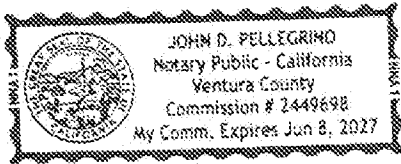
