**TRADEMARK ASSIGNMENT**  
**(US and Canadian Marks)**

THIS TRADEMARK ASSIGNMENT is effective as of October 1, 2023 (the “**Effective Date**”), by and between HBI Branded Apparel Enterprises, LLC, a limited liability company organized under the laws of Delaware with a principal place of business at 1001 East Hanes Mill Road, Winston-Salem, North Carolina (“**Assignor**”), and L’EGGS IP LLC, a limited liability company organized under the laws of Delaware with a principal place of business at 15 Riverside Avenue, Westport, Connecticut (“**Assignee**”).

WHEREAS, Assignor is the owner of the trademarks listed in the attached **Schedule A** (“**Assigned IP**”) and is the owner of the registrations listed in the Schedule; and

WHEREAS, pursuant to a certain Asset Purchase Agreement dated March 24, 2023, Assignor has agreed to assign the Assigned IP to Assignee; and

WHEREAS, pursuant to that Asset Purchase Agreement dated March 24, 2023, Assignor has also agreed to take (at Assignee’s sole cost and expense) such steps and actions, and provide such reasonable cooperation and assistance to the Assignee and its successors, assigns, and legal representatives, in the execution and delivery of any such other documents, certificates, agreements and other writings as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned IP to the Assignee, or any assignee or successor thereto; and

WHEREAS, Assignee, as a successor to that portion of the business to which the Assigned IP pertains, is desirous of accepting said assignment.

NOW THEREFORE, in consideration of ten dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee full right to and title in the Assigned IP together with the goodwill of the business symbolized by the Assigned IP and the right to recover for damages and profits and all other remedies for past infringements thereof, as of the Effective Date.

Assignor further authorizes the Assignee to proceed with the necessary recordal before the United States Patent and Trademark Office and the Canadian Intellectual Property Office.
