**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

This GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this “Agreement”), dated as of October 12, 2023, is entered into by **AMSCAN INC.**, a New York corporation with principal offices at 100 Tice Blvd, Woodcliff Lake, New Jersey 07677, **AM-SOURCE, LLC**, a Rhode Island limited liability company with principal offices at 261 Narragansett Park Dr, Rumford, Rhode Island 02916, **PARTY CITY CORPORATION**, a Delaware corporation with principal offices at 100 Tice Blvd, Woodcliff Lake, New Jersey 07677, **PARTY CITY HOLDINGS INC.**, a Delaware corporation with principal offices at 100 Tice Blvd, Woodcliff Lake, New Jersey 07677, and **TRISAR, INC.**, a California corporation with principal offices at 2200 Orangewood Avenue, Suite 235, Orange, California 92868 (each, a “Grantor” and together, the “Grantors”) and **JPMORGAN CHASE BANK, N.A.**, a United States banking association with offices at 131 S. Dearborn St., Floor 04, Chicago, Illinois 60603-5506, as administrative agent and collateral agent for the lenders party to the ABL Credit Agreement (collectively, in such capacities, the “Grantee”).

WHEREAS, the Grantors are the owners of all right, title and interest in and to the United States Trademarks (as such term is defined in the ABL Security Agreement referred to below), including the associated United States trademark registrations and applications for registration set forth in Schedule A attached hereto (collectively, the “Trademark Collateral”);

WHEREAS, Grantee desires to acquire a security interest in the Trademark Collateral; and

WHEREAS, each Grantor is willing to grant to the Grantee a security interest in and lien upon the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and subject to the terms and conditions of the Pledge and Security Agreement, dated as of October 12, 2023, made by the Grantors, the other assignors from time to time party thereto and the Grantee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “ABL Security Agreement”), the Grantors and Grantee agree as follows:

i. Definitions

Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the ABL Security Agreement.

ii. Grant of Security Interest

a. As security for the prompt and complete payment or performance when due (whether at stated maturity, acceleration or otherwise), as the case may be, in full of the Secured Obligations, each Grantor hereby pledges, collaterally assigns, mortgages, transfers and grants to the Grantee, its successors and permitted assigns, on behalf of and for the benefit of the Secured Parties, a continuing security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including (i) the goodwill of the business symbolized by the foregoing; (ii) all renewals of the foregoing; (iii) all Proceeds and products of the foregoing; (iv) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringement or other violation thereof; (v) all rights to sue for past, present, and future infringement or other violation of the foregoing, including the right to settle suits involving claims and demands for royalties

owing; and (vi) all domestic rights corresponding to any of the foregoing. Notwithstanding the foregoing, the Trademark Collateral shall not include any intent-to-use (or similar) Trademark applications prior to the filing of a "Statement of Use" or "Amendment to Allege Use" with respect thereto, to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein may impair the validity or enforceability of such intent-to-use Trademark applications under applicable law.

b. This Agreement has been granted in conjunction with the security interest granted to the Grantee under the ABL Security Agreement. The rights, immunities, privileges, protections, indemnities and remedies of the Grantee with respect to the security interest granted herein are as set forth in the ABL Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the ABL Security Agreement, the provisions of the ABL Security Agreement shall govern.

iii. Termination of Security Interest

Upon the occurrence of the termination of the ABL Security Agreement, the Grantee shall execute, acknowledge, and deliver to the Grantors an instrument in writing releasing the security interest in the Trademarks acquired under this Agreement.

iv. Authorization; Constitution

To the extent applicable, the parties hereto authorize and request that the Commissioner of Trademarks of the United States Patent and Trademark Office (and, as applicable, the corresponding entities or agencies in any applicable foreign countries) to record this security interest in the Trademark Collateral.

v. Governing Law

**THIS AGREEMENT AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS AGREEMENT, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.**

vi. Successors and Assigns

This Agreement shall be binding upon and inure to the benefit of the Grantee, the Grantors and their respective successors and assigns. The Grantors shall not, without the prior written consent of the Grantee given in accordance with the ABL Security Agreement, assign any right, duty or obligation hereunder.

vii. [Reserved].

viii. Counterparts

This Agreement may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or by email as a ".pdf" or ".tif" attachment or other customary means of electronic transmission shall be as effective as delivery of a manually executed counterpart of this Agreement. The words "execution," "signed," "signature," and words of like import in


this Agreement shall be deemed to include electronic signatures or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
