TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Termination and Release*”) is granted as of August 18, 2023 by **TREE LINE CAPITAL PARTNERS, LLC**, in its capacity as collateral agent for certain secured parties (in such capacity, the “*Agent*”), in favor of **DASH MEDICAL GLOVES, LLC**, a Wisconsin limited liability company (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of March 2, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Trademark Security Agreement*”), granting the Agent a security interest in and lien on the Trademark Collateral (as defined in the Trademark Security Agreement), which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on March 2, 2021, at Reel 7207, Frame 0803;

WHEREAS, the Grantor has requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral as herein provided; and

WHEREAS, the Grantor has requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:


1. terminates the Trademark Security Agreement and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Trademark Collateral, including without limitation those trademarks and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Trademark Collateral, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and

2. authorizes and requests that this Termination and Release be recorded with the USPTO.
