2. Each party hereto will, at Assignee's expense, take such further actions and execute promptly such further documents as are necessary to effect the above assignment.

3. This Trademark Assignment shall be governed by and construed in accordance with the internal laws (without regard to conflicts of law provisions) of the State of Delaware.
