**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 16, 2023 (“Release”), is made by Fifth Third Bank, National Association (“Lender”) in favor of Thorne HealthTech, Inc., a Delaware corporation (“Obligor”).

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of December 21, 2022 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Obligor, Lender, and others party thereto, Obligor pledged, assigned, hypothecated, transferred, conveyed, delivered and granted to the Lender, a continuing Lien upon and security interest in all of its right, title and interest in, to and under all Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Obligor executed and delivered to Lender the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on December 22, 2022 at Reel 7928 Frame 0576 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Obligor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice, as applicable.

SECTION 2. Termination and Release. Lender, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing Lien upon and security interest in any and all right, title and interest of Obligor in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and


(b) authorizes the recordation of this Release with the USPTO at Obligor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflict of laws principles.
