Pursuant to Section 264 of the General Corporation Law of the State of Delaware (the "DGCL"), Boston Scientific Neuromodulation Corporation, a Delaware corporation ("BSNC"), hereby certifies to the following information relating to the merger of Cosman Medical, LLC, a Massachusetts limited liability company ("CML"), with and into BSNC (the "Merger"), pursuant to the Agreement and Plan of Merger dated as of May 10, 2021 by and between BSNC and CML (as the same may be amended from time to time, the "Merger Agreement").

FIRST: The constituent business entities ("Constituent Entities") participating in the Merger are:

- (a) Boston Scientific Neuromodulation Corporation, which is incorporated under the laws of the State of Delaware; and
- (b) Cosman Medical, LLC, which is organized under the laws of the Commonwealth of Massachusetts.

SECOND: The Merger Agreement has been approved, adopted, certified, executed and acknowledged by the Constituent Entities in accordance with the DGCL and the Massachusetts Limited Liability Company Act.


THIRD: The surviving business entity in the Merger is BSNC, which will continue its existence as the surviving corporation (the "Surviving Corporation") under its present name upon the effective time and date of the Merger pursuant to the provisions of the DGCL.

FOURTH: The merger shall become effective as of May 31, 2021.

- FIFTH:** The Merger Agreement is on file at 25155 Rye Canyon Loop, Valencia, California 91355, the place of business of the Surviving Corporation.
- SIXTH:** A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder or member of the Constituent Entities.
- SEVENTH:** The certificate of incorporation and bylaws of the Surviving Corporation, each as in effect immediately prior to the Merger, shall be the certificate of incorporation and bylaws of the Surviving Corporation.
