TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 16, 2023, by BMO BANK N.A. (formerly known as BMO Harris Bank N.A.), as Grantee (as defined in the Trademark Security Agreement referred to below).

W I T N E S S E T H:

WHEREAS, Grantee and FRIENDLY FINANCE CORPORATION, a Maryland Corporation ("Grantor"), were parties to that certain Trademark Security Agreement dated as of September 18, 2019 (the "Trademark Security Agreement" capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement), pursuant to which Grantor granted a security interest to Grantee in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the trademarks and service marks listed on the attached Schedule 1 which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks"); and

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 18, 2019, at Reel 6748, Frame 0046; and

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its continuing security interest in all of Grantor's right, title and interest in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Trademark Collateral").

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.

3. Grantee hereby further authorizes and consents that this release may be recorded and indexed by the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office.
