## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (“Agreement”) dated as of July 31st, 2023 (the “Effective Date”) by and between:

- (i) UNIVERSAL ENTERTAINMENT CORPORATION, a Japanese corporation incorporated under the laws of Japan, with its registered office presently located at Ariake Frontier Building, Tower A 3-7-26 Ariake, Koto-Ku, Tokyo, Japan (“Universal”); and
- (ii) ARUZE GAMING AMERICA, INC., a Nevada corporation incorporated under the laws of the State of Nevada, with its registered office presently located at 6900 S. Decatur Blvd., Suite 100, Las Vegas, NV 89118 (“AGA”). AGA and Universal are individually referred to herein as a “Party” and collectively as the “Parties.”

### WITNESSETH:

WHEREAS, Universal and AGA have entered into a Settlement Agreement (“Settlement Agreement”) to, *inter alia*, settle certain litigation between the Parties, which has been filed with the United States Bankruptcy Court for the District of Nevada in *In re Aruze Gaming America, Inc.*, Chapter 11 Case No. 23-10356-abl, ECF No. 343, and subsequently approved by that court.

WHEREAS, pursuant to that Settlement Agreement, Universal and AGA have agreed to enter into, and now wish to enter into, this Agreement assigning to AGA certain intellectual property (the “AGA Assigned Patents” and the “Assigned Trademarks,” defined below).

WHEREAS, this Agreement is intended to constitute the “Trademark Assignment Agreement” and one of the “Patent Assignment Agreement(s)” set forth in the Settlement Agreement.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and agreements contained in this Agreement, and for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Patent Assignment to AGA. Universal hereby irrevocably assigns, conveys and transfers to AGA its right, title, and interest in and to all of the patents and patent applications set forth on Schedule A attached hereto (collectively, the “AGA Assigned Patents”), in each case, subject to all existing encumbrances, expressly including the license granted to Universal by the Settlement Agreement. Pursuant to the foregoing

assignment, each of the AGA Assigned Patents shall hereafter be for AGA's own use and enjoyment, and for the use and enjoyment of AGA's successors and assigns, as fully and entirely as the same would have been held and enjoyed by Universal if this Agreement had not been made. The foregoing assignment includes, without limitation, the rights of Universal, if any, to (A) register or apply in all countries and regions for patents, utility models, design registrations and like rights of exclusion and for inventors' certificates for the AGA Assigned Patents; (B) prosecute, maintain and defend the AGA Assigned Patents before any public or private agency, office or registrar including by filing divisions, substitutes, extensions and all other applications and post-issuance proceedings included in the AGA Assigned Patents; (C) claim priority based on the filing dates of any of the AGA Assigned Patents under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, the Paris Convention, and all other treaties of like purposes; and (D) all causes of action, remedies and other enforcement rights relating to the AGA Assigned Patents including the right to initiate and maintain legal proceedings in respect of any past, present or future infringements thereof and to seek and recover damages or other compensation in respect of such infringements and obtain equitable relief, including injunctive relief, in respect of such infringements, and the right to fully and entirely stand in the place of the applicable assignor in all matters related to the AGA Assigned Patents.

2. Trademark Assignment. Universal hereby irrevocably assigns, conveys and transfers to AGA its right, title, and interest in and to all of the trademarks and trademark applications set forth on **Schedule B** attached hereto (collectively, the "Assigned Trademarks"), in each case, subject to all existing encumbrances, and together with the part of the goodwill of the business connected with the use of and symbolized by the Assigned Trademarks. Pursuant to the foregoing assignment, each of the Assigned Trademarks shall hereafter be for AGA's own use and enjoyment, and for the use and enjoyment of AGA's successors and assigns, as fully and entirely as the same would have been held and enjoyed by Universal if this Agreement had not been made. The foregoing assignment includes, without limitation, the rights of Universal, if any, to (A) the goodwill of the business relating to the products and services on which the marks are used and for which they are registered; (B) prosecute, maintain and defend the Assigned Trademarks before any public or private agency, office or registrar including by filing divisions, substitutes, extensions and all other applications and post-issuance proceedings included in the Assigned Trademarks; (C) claim priority based on the filing dates of any of the Assigned Trademarks; (D) all common law trademark rights deriving from the Assigned Trademarks; and (E) all causes of action, remedies and other enforcement rights relating to the Assigned Trademarks including the right to initiate and maintain legal proceedings in respect of any past, present or future infringements thereof and to seek and recover damages or other compensation in respect of such infringements and obtain equitable relief, including injunctive relief, in respect of such infringements, and the right to fully and entirely stand in the place of Universal in all matters related to the Assigned Trademarks.

3. Authorization. Universal also hereby expressly authorizes the respective patent and/or trademark office or governmental agency in each and every jurisdiction worldwide (including the Commissioner for Patents and the Commissioner for Trademarks

in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities) (the "Applicable IP Offices") to: (A) issue any and all patents or certificates of invention or equivalent which may be granted upon any of the AGA Assigned Patents in the name of AGA, as the assignee to Universal's interest therein; (B) issue any and all trademark registrations or equivalent that may be granted upon any of the Assigned Trademarks in the name of AGA, as the assignee to Universal's interest therein; and (C) record AGA as the assignee of the AGA Assigned Patents and the Assigned Trademarks and to deliver to AGA, and to AGA's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Agreement.

4. Further Assurances. In the event that one Party (the "First Party") reasonably believes it to be necessary for the other Party (the "Second Party") to execute a document, provide a notarization, or take similar action to confirm or effect the assignments set forth in this Agreement, or otherwise to carry out the purposes of this Agreement (including, without limitation, by providing executed originals of this Agreement entered into by the Parties on the Effective Date for filing or otherwise evidencing the assignments set forth in this Agreement with the Applicable IP Offices), the Second Party hereby agrees to take reasonable steps to execute such document, provide such notarization, or take such action, provided, however, that (1) the burden of preparing any documents shall fall on the First Party, (2) any required costs for any notarization shall be paid by the First Party, and (3) nothing contained herein shall obligate the Second Party to incur any cost or pay any expense in connection with fulfilling the obligations of this paragraph.

5. Governing Law. This Agreement and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Agreement and the transactions contemplated hereby shall be governed by the laws of the State of Nevada, U.S.A., without giving effect to any choice or conflict of law provision or rule (whether of the State of Nevada or any other jurisdiction).

6. Terms of the Settlement Agreement. The Parties acknowledge and agree that this Agreement is entered into pursuant to the Settlement Agreement, to which reference is made for a further statement of the rights and obligations of each Party with respect to the assignments under this Agreement. The representations, warranties, releases, and any other terms in the Settlement Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Settlement Agreement and the terms of this Agreement, the terms of the Settlement Agreement shall govern.

7. General Provisions. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or electronic mail shall be as effective as delivery of a manually executed counterpart of this Agreement. This Agreement may not be supplemented, altered, or modified in any manner except by a writing signed by the


Parties. The failure of any Party to enforce any terms or provisions of this Agreement shall not waive any of its rights under such terms or provisions.


