**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”) dated as of October 17, 2023, from Bank of America, N.A., in its capacity as administrative agent (the “Administrative Agent”), in favor of MIRACHEM, LLC, a Delaware limited liability company and HERITAGE-CRYSTAL CLEAN, LLC, an Indiana limited liability company (each a “Grantor”).

WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement, dated as of March 18, 2021 (the “Trademark Security Agreement”), the Administrative Agent was granted a security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement) from the Grantor (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the “USPTO”) on March 18, 2021 at Reel 7224, Frame 0752; and

WHEREAS, the Administrative Agent, on behalf of itself and the Lenders and the Secured Parties, now wishes to release its liens on, and security interests in, the Trademark Collateral, including, without limitation, the trademarks and trademark applications set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent, on behalf of itself and the Lenders and Secured Parties, and their respective successors, indorsees, transferees and assigns, hereby terminates the Trademark Security Agreement and terminates, irrevocably releases and fully discharges all of its and any Lender’s and Secured Party’s security interest and lien in, to and under the Trademark Collateral, and reassigns, re-transfers, and re-conveys any and all right, title and interest that it or any Lender or Secured Party may have in or to the Trademark Collateral to the Grantor.


2. Recordation. The Grantor or its authorized agent is authorized to record this Agreement with the USPTO.

3. Further Assurances. The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at the Grantor’s cost and expense, to more fully and effectively effectuate the release of liens and security interests contemplated hereby.
