RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 22, 2023 by Royal Bank of Canada, acting as administrative agent hereunder for the Lenders as defined in the Security Agreement referred to below (“RBC” acting as such administrative agent being hereinafter referred to as “Agent”);

WITNESSETH:

WHEREAS, Tucows (Delaware) Inc., a Delaware corporation (“Debtor”), executed that certain Trademark Security Agreement dated August 8, 2022 in favor of Agent which was recorded in the United States Patent and Trademark Office on August 15, 2022 at Reel 7822, Frame 0818 (the “Agreement”), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “Trademark Property”); and



(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
