**RELEASE OF TRADEMARK SECURITY INTEREST**

This RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of October 19, 2023, by TREEHOUSE FOODS, INC., in its capacity as Collateral Agent (the “Collateral Agent”) for the benefit of WINLAND FOODS, INC. a Delaware corporation, (f/k/a Meal Preparation, Inc.), AMERICAN ITALIAN PASTA COMPANY, a Delaware corporation, THE CARRIAGE HOUSE COMPANIES, INC., a Delaware corporation, S.T. SPECIALTY FOODS, INC., a Minnesota corporation, and ASSOCIATED BRANDS, INC., a New York Corporation, all located at 2015 Spring Rd., Suite 400, Oak Brook, Illinois 60523 (each a “Grantor” and collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Term Loan Credit Agreement (as defined below), the Term Loan Collateral Agreement (as defined below) or the Term Loan Security Agreement (as defined below) as applicable.

**W I T N E S S E T H:**

WHEREAS, the Grantors and Collateral Agent are parties to that certain (i) Credit Agreement, dated as of October 3, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Term Loan Credit Agreement”); (ii) Term Loan Collateral Agreement, dated as of October 3, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Term Loan Collateral Agreement”); and (iii) Term Loan Trademark Security Agreement, dated as of October 3, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Term Loan Security Agreement”), pursuant to which the Grantors have granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantors in, to and under the Trademark Collateral (as defined in the Term Loan Security Agreement), including the trademarks set forth on Schedule A; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (“USPTO”) on October 6, 2022 at Reel 7841 and Frame 0294; and

WHEREAS, the Grantors have requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral, including, without limitation, the trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Term Loan Credit Agreement, Term Loan Collateral Agreement, and Term Loan Security Agreement to the Trademark Collateral, including, without limitation, the trademarks (including the trademark registrations and trademark applications) set forth on Schedule A hereto, the goodwill of the business symbolized by the trademarks and the applications and registrations thereof, and all proceeds thereof, and any

right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Trademark Collateral to the Grantors.

2. The Collateral Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the Term Loan Security Agreement.

3. The Collateral Agent hereby authorizes the Grantors or the Grantors' authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Collateral Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments prepared by the Grantors, and do any and all further acts which the Grantors (or its agents or designees) reasonably request (at the Grantors' sole cost and expense) in order to confirm this Release and the Grantors' right, title and interest in, to and under the Trademark Collateral.

4. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

5. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
