**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of October 19, 2023 from TD Bank, N.A., a National Banking Association (as successor in interest to Commerce Bank, N.A.), having an address at 1701 Route 70 East, Cherry Hill, New Jersey, 08034, (the "**Lender**") in favor of **Penetone Corporation**, a New Jersey corporation having an address at 700 Gotham Parkway, Carlstadt, New Jersey, 07072 ("**Grantor**").

WITNESSETH:

WHEREAS, the Grantor, Petron Corporation, a Wisconsin corporation and West Chemical Products, Inc., a New York corporation, and the Lender are parties to certain Loan and Security Agreement, date October 29, 2001 (as amended, supplemented, restated or otherwise modified from time to time, the "**Loan Agreement**").

WHEREAS, pursuant to the Loan Agreement and the Trademark and Tradename Security Agreement and Mortgage, dated as of October 29, 2001, made by the Grantor (as defined therein) in favor of the Lender ( as amended, supplemented, restated or otherwise modified from time to time, the "**Collateral Agreement**"), a security interest (the "**Security Interest**") was granted by the Grantor to the Lender in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded in the United States Patent and Trademark Office on November 2, 2001 at Reel 2392 and Frame 0923; and

WHEREAS, Lender now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on **Schedule A** and all other Collateral. The term "Collateral" shall have the meaning provided by reference in the Collateral Agreement.

2. Release of Security Interest. The Lender hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Lender in such Trademark Collateral shall hereby cease and become void. Lender hereby acknowledges and agrees that the Grantor or any of its agents, attorneys or designees may prepare and file and/or deliver to the appropriate parties such UCC termination statements and/or other documents and notices as the Grantor may reasonably deem necessary or desirable in connection with the termination of the security interests and liens set forth in this Paragraph 2, without the signature of


the Lender or any other Person, to the extent permitted by law, in each case without recourse to the Lender or any other Person, without any representation or warranty of any kind, express or implied, and at the sole cost and expense of the Grantor.

3. Further Assurances. The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to affect the release of the Security Interest contemplated hereby.
