

Assignee shall be solely responsible for all costs and expenses arising out of the grant of rights hereunder

Notwithstanding the foregoing assignment, nothing in this Assignment shall abrogate, amend, or limit the Assignor's rights under any other agreement related to the use of the Trademark for the Series, including but not limited to Assignor's rights to use the trademark in relation to the production, distribution, marketing, and promotion of the Series under those certain License Agreements, by and between Assignor and Assignee, dated as of July 22, 2022, March 18, 2021, October 18, 2017, and December 16, 2016 (each as amended, supplemented and modified through the date hereof, collectively the "Show Agreements"). Assignee grants to Assignor the non-exclusive right to use (which includes without limitation, the right to display, produce, reproduce, and publish) the Trademark to identify, advertise, and promote the Series for which Assignor has distribution rights, and specials, of any length, related thereto.



Grace Period Filings*

The above documents will be accepted as timely if filed within six months after the deadlines listed above with the payment of an additional fee.

***ATTENTION MADRID PROTOCOL REGISTRANTS:** The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the United States Patent and Trademark Office (USPTO). The time periods for filing are based on the U.S. registration date (not the international registration date). The deadlines and grace periods for the Declarations of Use (or Excusable Nonuse) are identical to those for nationally issued registrations. See 15 U.S.C. §§1058, 1141k. However, owners of international registrations do not file renewal applications at the USPTO. Instead, the holder must file a renewal of the underlying international registration at the International Bureau of the World Intellectual Property Organization, under Article 7 of the Madrid Protocol, before the expiration of each ten-year term of protection, calculated from the date of the international registration.
