**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of October 18, 2023 by **WILMINGTON TRUST, NATIONAL ASSOCIATION** (“**Administrative Agent**”), in favor of **PTC THERAPEUTICS, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of October 27, 2022 (the “**Agreement**”), granting to the Administrative Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademark Collateral (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on October 28, 2022, at Reel 7879, Frame 0608.

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademark Collateral as herein provided; and

WHEREAS, Grantor has requested that the Administrative Agent provide a document suitable for recording with the USPTO to evidence the release of the Administrative Agent’s security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

This Agreement and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
