**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of October 20, 2023 (the “Effective Date”) by **FEAC AGENT, LLC** (as successor-in-interest to First Eagle Alternative Capital Agent, Inc.), as administrative agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacities, the “Agent”) in favor of **FIRST DOCS MSO, INC.**, a Delaware corporation (the “Grantor”).

**WHEREAS**, Grantor and certain other affiliates of Grantor executed and delivered that certain Security and Pledge Agreement, dated as of January 4, 2019 (the “Security Agreement”), in favor of the Agent. Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Security Agreement.

**WHEREAS**, pursuant to the terms of the Security Agreement, Grantor duly authorized the execution, delivery and performance of that certain Notice of Grant of Security Interest in Trademarks, dated as of July 27, 2022, in favor of the Agent (the “Trademark Security Agreement”).

**WHEREAS**, pursuant to the Trademark Security Agreement, Grantor pledged and granted to the Agent, for the benefit of the Secured Parties, a security interest in all of Grantor’s right, title and interest in, to and under all of the trademarks and trademark applications set forth on Schedule A attached hereto (collectively, the “Trademark Collateral”).

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 27, 2022 at Reel 7803, Frame 0280.

**WHEREAS**, Grantor has paid or caused to be paid all of the Obligations and has terminated the Commitments.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:



The Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels, releases, and discharges any and all liens and security interests it has in, to and under the Trademark Collateral and hereby reassigns any and all right, title and interest in and to any and all Trademark Collateral to the Grantor.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
