PARTIAL RELEASE OF 2018 SECURITY INTEREST IN TRADEMARKS

This **PARTIAL RELEASE OF 2018 SECURITY INTEREST IN TRADEMARKS** (this “Partial Release”) is made as of March 3, 2023 (“Effective Date”), by JPMORGAN CHASE BANK, N.A., as administrative agent (the “Administrative Agent”), in favor of AUREA SOFTWARE, INC., a Delaware corporation, and its successors and assigns, KERIO TECHNOLOGIES INC., a Delaware corporation, and its successors and assigns, NEXTDOCS CORPORATION, a Delaware corporation, and its successors and assigns and EXINDA INC., a Delaware corporation, and its successors and assigns (collectively, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of March 30, 2018 (as amended, modified or supplemented prior to the date hereof, the “2018 Trademark Security Agreement”), by and among the Administrative Agent and the Grantors, each Grantor granted to Administrative Agent a security interest in and to all of such Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the 2018 Trademark Security Agreement), including those trademarks listed on SCHEDULE A hereto (such trademarks listed on SCHEDULE A hereto, the “Released Trademarks”);

WHEREAS, the 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on March 30, 2018 at Reel 006313, Frame 0924; and


WHEREAS, the Administrative Agent has agreed to terminate, cancel and release any and all interest it has solely in the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby: terminates, cancels and releases any and all security interests it has in the Released Trademarks, and hereby re-assigns, conveys and transfers to the Grantors any right, title and interest that the Administrative Agent may have in the Released Trademarks;

Nothing herein is, or shall be deemed, a termination, cancellation, release or other modification of Administrative Agent’s security interests or liens on any of the Trademark Collateral other than the Released Trademarks. Except as to the Released Trademarks, the security interests and liens of Administrative Agent in the Trademark Collateral (including all other Trademark Collateral listed on Schedule I to the 2018 Trademark Security Agreement) shall continue in full force and effect as if this Partial Release had not been provided.
