THIS RELEASE OF TRADEMARK SECURITY INTEREST, dated as of October 16, 2023 (this “Release”), by JPMORGAN CHASE BANK, N.A. (“JPMCB”), as Administrative Agent (in such capacity, the “Administrative Agent”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreements, as applicable, referred to below.

Reference is made to (a) the Credit Agreement dated as of August 22, 2011, as amended and restated as of July 25, 2013, as further amended and restated as of March 31, 2016, as further amended and restated as of August 28, 2019 (as amended by (I) that certain First Amendment, dated as of October 7, 2019, (II) that certain Second Amendment, dated as of April 7, 2020, (III) that certain Third Amendment, dated as of January 22, 2021, (IV) that certain Fourth Amendment, dated as of February 4, 2021, (V) that certain Incremental Revolving Facility Agreement, dated as of February 16, 2021, (VI) that certain Incremental Term Loan A Facility Agreement, dated as of February 16, 2021, (VII) that certain Incremental Revolving Facility Agreement (TLA-2 Conversion), dated as of June 24, 2021, (VIII) that certain Fifth Amendment, dated as of December 27, 2022, (IX) that certain Sixth Amendment, dated as of June 30, 2023 and (X) that certain Seventh Amendment, dated as of August 31, 2023 (as further amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among NCR Corporation, a Maryland corporation (the “Borrower”), the Foreign Borrowers party thereto, the lenders from time to time party thereto (the “Lenders”) and the Administrative Agent, (b) the Guarantee and Collateral Agreement dated as of August 22, 2011, as amended and restated as of January 6, 2014, and as further amended and restated as of March 31, 2016 (as further amended, supplemented or otherwise from time to time, the “Collateral Agreement”), among the Borrower, the Foreign Borrowers from time to time party thereto, the subsidiaries of the Borrower from time to time party thereto (collectively, the “Grantors”) and the Administrative Agent, (c) the Trademark Security Agreement dated as of January 6, 2014 (the “2014 Trademark Security Agreement”) among the Borrower (“the Grantor”), each subsidiary of the Borrower party thereto and the Administrative Agent, (d) the Trademark Security Agreement dated as of March 31, 2016 (the “2016 Trademark Security Agreement”) among the Borrower (“the Grantor”), each subsidiary of the Borrower party thereto and the Administrative Agent, (e) the Trademark Security Agreement dated as of August 28, 2019 (the “2019 Trademark Security Agreement”) among the Borrower (the “Grantor”), each subsidiary of the Borrower party thereto and the Administrative Agent (b), (c), (d) and (e) together, the “Security Agreements”).

WHEREAS, pursuant to the Security Agreements, each Grantor granted a security interest in favor of the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, in all right, title and interest of such Grantor, whether now owned or at any time hereafter acquired by such Grantor, in, to and under (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, domain names, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar office in any State of the United States of America or any other country or any political subdivision thereof, all extensions or

renewals thereof, and all common law rights related thereto, including any of the foregoing listed on Schedule I, (b) all goodwill associated therewith or symbolized thereby and (c) all other assets, rights and interests that uniquely reflect or embody such goodwill with respect to the assets described under the foregoing clauses (a), (b) and (c) (the assets described under such clauses collectively, the “Released Trademark Rights”). The 2014 Trademark Security Agreement was recorded with the United States Trademark and Trademark Office on January 15, 2014 on Reel 5193, Frame 0567. The 2016 Trademark Security Agreement was recorded with the United States Trademark and Trademark Office on April 18, 2016 on Reel 5773, Frame 0109. The 2019 Trademark Security Agreement was recorded with the United States Trademark and Trademark Office on October 31, 2019 on Reel 6782, Frame 0333.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (a) releases any and all security interests it has pursuant to the Security Agreements in and against the Released Trademark Rights and (b) reassigns all right, title and interest it may have in, to or under the Released Trademark Rights, together with the goodwill associated therewith, to the Borrower. The Administrative Agent shall promptly execute and deliver all documents that the Borrower shall reasonably request to evidence such release and reassignment.


