ASSIGNMENT OF SECURITY INTEREST IN
TRADEMARK COLLATERAL

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Assignment"), dated as of October 24, 2023, is entered into by and between GOLDMAN SACHS CREDIT PARTNERS L.P. ("Assignor") and CITIBANK, N.A. ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the Trademark Security Agreement referred to below, whether defined therein or by reference to another agreement.

WHEREAS, pursuant to that certain Security Agreement, dated as of August 17, 2007 (as amended, restated, supplemented or otherwise modified, refinanced or replaced from time to time, the "Security Agreement") among Laureate Education, Inc. (the "Grantor"), a Delaware corporation, and certain of its Subsidiaries, and Assignor, Grantor executed and delivered that certain Trademark Security Agreement, dated as of April 24, 2009 (the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office ("USPTO") on May 5, 2009 at Reel/Frame 4020/0515;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Grantor bargained, sold, conveyed, set over, mortgaged, pledged, hypothecated, transferred, and granted to the Assignor, for the ratable benefit of the Secured Parties, a lien on and security interest in (the "Security Interest") all of its right, title and interest in, to and under all of the following property then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time in the future may acquire any right, title or interest: (i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof (if any), and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof including those listed on Schedule A hereto, (ii) all goodwill associated therewith or symbolized thereby, (iii) all other assets, rights and interests that uniquely reflect or embody such goodwill, and (iv) all rights, priorities and privileges relating to the foregoing, including all rights to sue at law or in equity for any past, present or future infringement, dilution or other impairment thereof, including the right to receive all Proceeds therefrom; but excluding "intent-to-use" applications to the extent set forth therein (collectively, and to the extent not previously released, the "Trademark Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations;

WHEREAS, pursuant to a Resignation and Appointment Agreement, dated as of September 30, 2011, the Assignor assigned to Assignee, and Assignee assumed, all of Assignor's rights and obligations under the Security Agreement and the Trademark Security Agreement and the liens granted thereunder; and


WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the USPTO.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, without recourse, warranty or representation, express or implied, statutory or otherwise, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under the Trademark Collateral and the Trademark Security Agreement, including, without limitation, the Security Interest in the Trademark Collateral.


