RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made by **WESTERN ALLIANCE BANK**, a corporation of Arizona (the "**Bank**"), in favor of **CECELIA HEALTH, INC.**, a corporation of Delaware, having an address of 355 Lexington Avenue, New York, NY 10017 ("**Grantor**").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby terminates the Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Trademarks and hereby assigns and transfers any and all interest Bank may have in and to the Trademarks.

Bank shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

Bank hereby authorizes Grantor to record this Release with the United States Patent and Trademark Office and any other relevant agency throughout the world.



