RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of October 24, 2023 (this “Release”), is made by ANTARES CAPITAL LP, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Agent”) for the Secured Parties (as defined in the Credit Agreement) in favor of ON TIME HEATING, COOLING, PLUMBING & ELECTRICAL, LLC, a Delaware limited liability company, TRADE UP ACADEMY, LLC, a Delaware limited liability company, WEST ALLIS HEATING, COOLING, PLUMBING & ELECTRICAL, LLC, a Delaware limited liability company, M. N. MAUZY MECHANICAL, INC., a California corporation, TRITON AIR, INC., a California corporation, and CALL THE BEE HEATING, COOLING, PLUMBING & ELECTRICAL, LLC, a Delaware limited liability company (collectively, the “Grantors” and each, a “Grantor”).

**WITNESSETH**

WHEREAS, Apex Service Partners Intermediate, LLC, a Delaware limited liability company, Apex Service Partners, LLC, a Delaware limited liability company, the other parties party thereto from time to time, and Agent, entered into that certain Credit Agreement, dated as of July 31, 2019 (as the same may be amended, restated, amended and restated, modified, and/or supplemented from time to time, the “Credit Agreement”) and the Grantors and the Agent entered into that certain Guaranty and Security Agreement, dated as of July 31, 2019 (the “Guaranty and Security Agreement”);

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantors executed the Trademark Security Agreement, dated as of June 7, 2023 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on June 7, 2023 at Reel/Frame Nos. 8122/0271, 8094/0637, 8094/0648, and 8094/0659, pursuant to which the Grantors mortgaged, pledged and hypothecated to Agent for the benefit of the Secured Parties, and granted to Agent for the benefit of the Secured Parties a Lien on and security interest in, all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantors have requested that the Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Trademark Security Agreement.
