TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of October 25, 2023 (“Release”), is made by Atlantic Union Bank (successor-in-interest to Access National Bank) (“Bank”), in favor of ByteCubed LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Amended and Restated Loan and Security Agreement dated as of December 17, 2018 (as amended, modified or supplemented from time to time, the “Security Agreement”) by and among the Grantor, Bank, and other Persons party thereto and the Intellectual Property Security Agreement dated as of January 29, 2019 (“IP Security Agreement”) by and among the Grantor and Bank, Grantor granted and pledged to the Bank a security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property Collateral; and

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on January 30, 2019 at Reel 6573 Frame 0558, on November 6, 2019 at Reel 6789 Frame 0597, and September 8, 2020 at Reel 7046 Frame 0457.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Obligor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Virginia.

IN WITNESS WHEREOF, the Bank has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
