TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Assignee desires to acquire all rights, title, and interest in and to the Marks and all associated goodwill in said Marks;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignment. Assignor hereby irrevocably assigns and transfers to Assignee its successors and assigns all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, along with the registrations thereof, the number of which are contained herein.
2. Recordal. Assignor hereby authorizes Assignee’s representatives to execute the necessary applications, registrations and proprietorship forms for recordal with the respective U.S. and worldwide trademark offices.
3. Authority. The Parties hereto represent and warrant that they have full power and authority to execute, deliver and perform this Agreement and such other instruments as required herein and to consummate the transactions contemplated hereby.
4. Governing Law; Venue. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois (regardless of the laws that might otherwise govern under applicable Illinois conflict of laws principles). The Parties hereby agree that the courts sitting in Chicago, Illinois shall have exclusive jurisdiction over any dispute, claim or controversy between the parties.


