Partial Release of Trademark Security

This **Partial Release of Trademark Security** (this “**Release**”), dated as of November 1, 2023, is made by BANK OF AMERICA, N.A., in its capacity as administrative agent and collateral agent (in such capacities, the “**Administrative Agent**”), in favor of The AZEK Group LLC (f/k/a CPG International LLC) (the “**Released Pledgor**”). Capitalized terms used but not defined herein shall have the meaning given to them in the Trademark Security Agreement (whether defined directly therein or by reference to another agreement).

WITNESSETH:

WHEREAS, the Released Pledgor, together with another Pledgor and the Administrative Agent, are parties to that certain (i) Term Loan Guarantee and Collateral Agreement dated as of April 28, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Term Loan Security Agreement**”), and (ii) that certain Trademark Security Agreement, dated April 28, 2022, which was recorded with respect to the Trademark Collateral of the Released Pledgor on April 28, 2022 at Reel/Frame 7705/0793 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Term Loan Security Agreement and the Trademark Security Agreement, each Pledgor, including the Released Pledgor, pledged and granted to the Administrative Agent a security interest (the “**Security Interest**”) in all of such Pledgor’s right, title and interest in or to the Trademark Collateral;

WHEREAS, the Trademark Collateral included (i) the Trademarks of the Released Pledgor listed on Schedule I attached hereto, and all renewals thereof; (ii) all goodwill associated therewith or symbolized thereby; (iii) all claims for, and rights to sue for, past or future infringements of any of the foregoing; (iv) all income, royalties, damages and payments then or thereafter due and payable with respect to any of the foregoing, including damages and payments for past or future infringement thereof; and (v) all Proceeds, Supporting Obligations and products of any and all of the foregoing and all collateral security and guarantees given by any person with respect to any of the foregoing (in each case (i) through (v), other than Excluded Assets, collectively, the “**Released Trademark Collateral**”); and

WHEREAS, Administrative Agent has agreed to terminate and release the Security Interest in the Released Trademark Collateral granted by the Released Pledgor under the Term Loan Security Agreement and the Trademark Security Agreement and reassign any and all rights in the same to the Pledgor.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficient of which are hereby acknowledged, the Administrative Agent hereby (i) terminates and releases the Security Interest in the Released Trademark Collateral which had been granted to it by the Released Pledgor pursuant to the Term Loan Security Agreement and the Trademark Security Agreement, and (ii) re-assigns to the Released Pledgor any right, title or interest it may have in the Released Trademark Collateral, in each case without

recourse to the Administrative Agent, or representation or warranty of any kind. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Administrative Agent in the Trademark Collateral (other than Released Trademark Collateral), or any other security interest granted by the Pledgors (including the Released Pledgor) to the Administrative Agent.

The Released Pledgor (and any successor to the Released Pledgor, including any person or entity hereafter holding any right, title or interest in and to the Released Trademark Collateral) is hereby authorized to record this Release with the United States Patent and Trademark Office, at the Released Pledgor's sole cost and expense.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
