BETWEEN

- (1) MISGUIDED RETAIL LIMITED incorporated and registered in England and Wales with company number 12298767 whose registered office is at Unit A, Brook Park East, Shirbrook, United Kingdom, NG26 8RY ("Assignor"); and
- (2) ROADGET BUSINESS PTE. LTD. incorporated and registered in Singapore with company number 201938698G whose registered office is at 12 Marina Boulevard, #15-01 Marina Bay Financial Centre, Singapore, 018982 ("Assignee").

INTRODUCTION

- (A) On or around the date of this Deed, the Assignor entered into the IPA (as defined below) with the Assignee.
- (B) As part of the IPA, the Assignor has agreed to assign to the Assignee the Assigned Rights (as defined in clause 2(a)(ii) below), on the terms and conditions of this Deed.

AGREED TERMS

1 DEFINITIONS AND INTERPRETATION

- (a) The following definitions and rules of interpretation apply in this Deed:

"Intellectual Property Rights" means all existing and future intellectual property rights, whether protected, created or arising under the laws of England or any other jurisdiction worldwide or under any international convention and all rights in, arising from or associated with such rights, including without limitation the following: copyrights, copyright registrations and applications and related rights, trade marks, domain names, social media accounts, uniform resource locators, email and other internet addresses, rights in get-up, trade secrets, know-how and other proprietary information, works of authorship, service marks, business names, brand names, trade names, trade dress, logos, slogans, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights to use, moral rights, rights of attribution and rights of publicity, in each case whether registered or unregistered and including (a) all applications and rights to apply for and be granted, renewals, extensions, revisions, revivals, restoration of such rights and all similar or equivalent rights or forms of protection which subsist in any part of the world and (b) all rights of action and the right to sue for and recover damages for infringement thereof;

"IPA" means the intellectual property purchase agreement dated on or around the date of this Deed among the Assignor, the Assignee and certain other party thereto;

"Purchased Assets" has the meaning given to it in the IPA;

"Residual IP" has the meaning given to it in the IPA;

"Territory" means worldwide;

2 ASSIGNMENT

(a) Pursuant to and for the corresponding consideration set out in the IPA and for the additional consideration of [REDACTED] (payable on demand by the Assignee to the Assignor), the Assignor hereby assigns to the Assignee, including by way of present assignment of future rights absolutely, all of the Assignor's right, title and interest in and to the following:

(i) the Original Acquired IP and the Residual IP including all such rights in the Trade Marks, free from Encumbrances created by the Assignor through its acts or omissions or under any agreement or instrument to which the Assignor is a party, [REDACTED]; and

(ii) with full title guarantee, all Purchased Assets other than those described in clause 2(a)(i) above, free from Encumbrances;

(and (i) and (ii) together are the "Rights");

including all of the Assignor's statutory and common law rights and goodwill attaching to the Rights (including the Trade Marks) in the Territory and the right to bring, make, oppose, defend and appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement or any other cause of action including passing off arising from ownership of any of the Rights (including the Trade Marks) (but excluding the right to claim and receive unpaid royalties [REDACTED] whether occurring before, on or after the date of this Deed (together the "Assigned Rights").

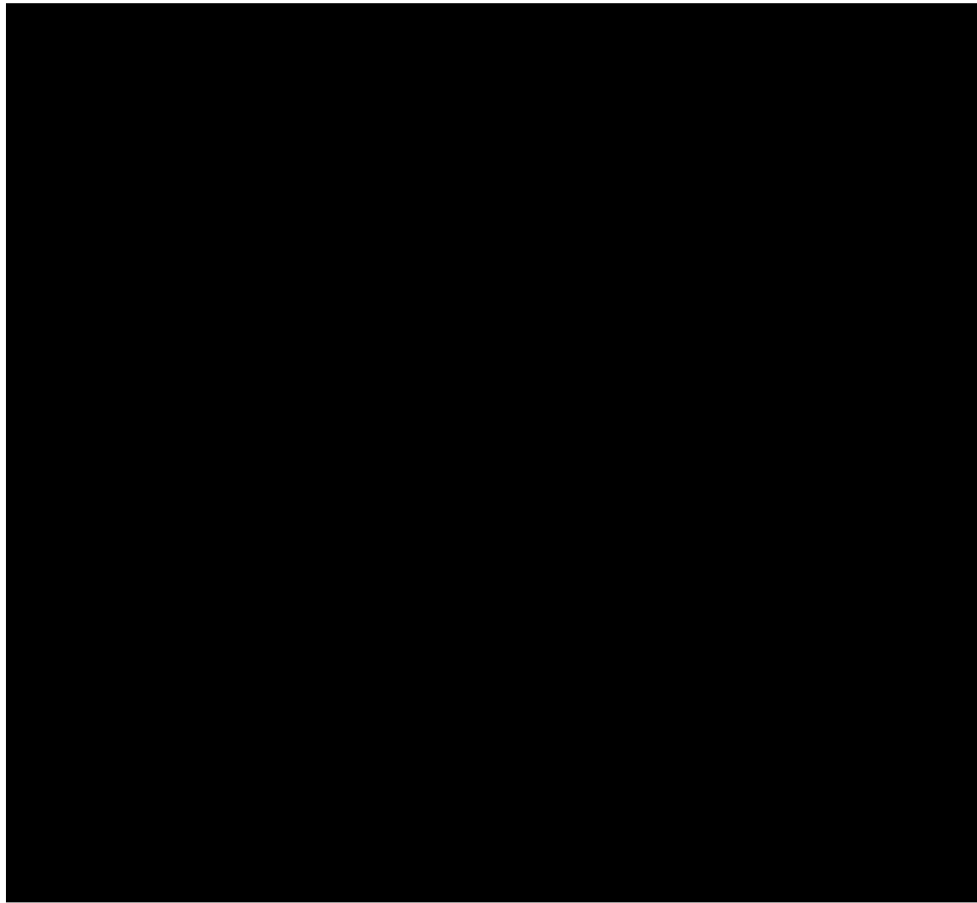


