**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of November 1, 2023 (“Release”), is made by **FIDUS INVESTMENT CORPORATION**, a Maryland corporation, as collateral agent (“Collateral Agent”) in favor of **CSI-PENN ARMS, LLC**, a Delaware limited liability company (“Pledgor”), pursuant to that certain Security Agreement dated January 31, 2020 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”).

**WHEREAS**, in connection with the Security Agreement, Pledgor executed and delivered a certain Grant in Security Interest in Patents and Trademarks, dated January 31, 2020 (the “IP Security Agreement”), which was recorded at the United States Patent and Trademark Office (“USPTO”) on February 3, 2020 at Reel 6854 and Frame 0219 and Reel 051696 and Frame 0001 (“Notices”), whereby Pledgor granted to Collateral Agent a security interest in any and all of Pledgor’s right, title, and interest in and to certain Patents and Trademarks, including the Patents and the Trademarks listed on Schedule A attached hereto.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent agrees as follows:


**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, without representation, warranty, or recourse, hereby irrevocably terminates the Notices and terminates, cancels, discharges, and releases the continuing security interest in Pledgor’s right, title, and interest in and to the Patents and Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the business symbolized by the Trademarks and the Patents, granted pursuant to the IP Security Agreement and the Notices. Collateral Agent hereby authorizes the Pledgor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Patents and Trademarks contemplated hereby. Collateral Agent agrees to execute and deliver to the Pledgor all other instruments and other documents as the Pledgor may reasonably request to release the security interest in the Patents and Trademarks which had been granted under the Notices, in each case, at the sole expense of the Pledgor.
