THIS NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS AND TRADEMARK APPLICATIONS dated as of November 1, 2023, by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Lender"), for its benefit and the benefit of any of its Affiliates party to any Related Credit Arrangement, pursuant to that certain Amended and Restated Security Agreement (the "Security Agreement") dated as of August 12, 2021 among NOVA U.S.A., INC., a Delaware corporation (the "Borrower"), certain Subsidiaries of the Borrower party thereto and the Lender, which amended and restated that certain Security Agreement dated as of December 22, 2016 among the Borrower, certain Subsidiaries of the Borrower party thereto and the Lender.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, SOURCE HOLDING DELAWARE, LLC, a Delaware limited liability company ("Source Holding"), and FULFILLMENT CORPORATION OF AMERICA, an Oregon corporation (and together with Source Holding, collectively, the "Grantors"), among others, entered into a Notice and Confirmation of Grant of Security Interest in Trademarks (the "Specified Trademark Notice") dated as of December 22, 2016, whereby a security interest (the "Security Interest") was granted by the Grantors to the Lender in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Specified Trademark Notice was recorded in the Trademark Division of the United States Patent and Trademark Office on December 22, 2016 at Reel 5950, Frame 0156; and

WHEREAS, the Lender has agreed to release its Security Interest in the Specified Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:


