CERTIFICATE OF MERGER OF
DOMESTIC CORPORATIONS**

Pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Unified Brands, Inc., a Delaware corporation (the "Surviving Corporation"), and the name of the corporation being merged into the Surviving Corporation is Electrolux Professional, Inc.

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by the Surviving Corporation and the merging corporation, in accordance with Delaware law.

THIRD: The name of the surviving corporation is Unified Brands, Inc., which name shall be changed pursuant to the SEVENTH paragraph below.


FOURTH: The merger is to become effective as of October 1, 2023 (the "Effective Time").

Except as set forth in the preceding sentence, the Certificate of Incorporation of the Surviving Corporation in effect immediately prior to the Effective Time shall remain unchanged and continue (until amended or repealed as provided by applicable law) to be the Certificate of Incorporation of the Surviving Corporation as the surviving business entity on and after the Effective Time.
