## **TERMINATION OF TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT, dated as of October 30, 2023 (this "Release", is made by ALLY BANK, in its capacity as agent for itself and the other lenders (together with its successors and assigns in such capacity, "Agent") in favor of Enovate Medical, LLC, a Delaware limited liability company (the "Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of July 7, 2017, by Grantor in favor of Agent's predecessor in interest Fifth Third Bank (the "Trademark Security Agreement"), Grantor granted to Fifth Third Bank a security interest in all right, title and interest of Grantor in and to certain intellectual property, including the trademark registrations and applications set forth in Schedule A (the "Trademark Collateral");

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on July 10, 2017 at Reel 6102 Frame 0092;

WHEREAS, pursuant to that certain Agency Resignation and Assignment Agreement dated as of October 31, 2019, between Fifth Third Bank, as former administrative agent and Agent, as successor administrative agent, Third Fifth Bank assigned to Agent all of its right, title and interest in and to the Security Agreement and the Trademark Collateral thereunder; and

**WHEREAS**, Grantor requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Secured Parties (as defined in the Trademark Security Agreement), (i) releases any and all liens, security interests, right, title and interest the Agent or any Secured Party may have in, to or under the Trademark Collateral, and (ii) hereby authorizes the Grantor or the Grantor's authorized representative or designee to record this Release with the USPTO as evidence of such release and termination

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


