RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “*Release*”) is made as of November 3, 2023 MMV Finance, Inc. (“*MMV*”), in favor of Ooma, Inc., a Delaware corporation (the “*Grantor*”).

WITNESSETH:

WHEREAS the Grantor executed that certain Confirmation of Grant of Security Interest, dated as of December 30, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”) in favor of MMV, pursuant to which the Grantor granted a security interest to MMV in certain trademarks and other intellectual property of the Grantor;

WHEREAS the Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 4449; Frame: 0802 on January 10, 2011; and

WHEREAS, MMV has agreed to terminate the Security Agreement and terminate and release the entirety of its security interest, including all its liens, on the trademarks and trademark applications of the Grantor identified on Annex 1 attached hereto and made a part hereof (the “*Trademark Collateral*”), and to reconvey any and all of its rights, title and interests in, to and under the Trademark Collateral to the Grantor.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, MMV hereby terminates the Security Agreement and the security interest and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of MMV in and to the Trademark Collateral and all rights, title and interests in, to and under the Trademark Collateral, all without warranty or representation of any kind.

This Release shall be governed by, and construed in accordance with, the law of the State of New York.
