RECITALS



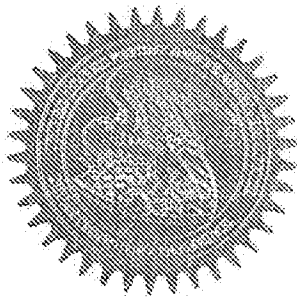
