**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of November 2, 2023, is made by CITIZENS BANK, N.A., as administrative agent under the Credit Agreement (as defined herein) (in such capacity, the "Administrative Agent"), in favor of STYLE CREST ENTERPRISES, INC., an Ohio corporation, STYLE CREST, INC., an Ohio corporation, STYLE CREST REAL ESTATE, INC., an Ohio corporation, PATRIOT SUPPLY, INC., a Michigan corporation, and DURHAM SUPPLY, INC., an Oklahoma corporation (collectively, the "Borrowers" and each a "Borrower"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined herein).

**WHEREAS**, pursuant to that certain (i) Credit Agreement, dated as of April 28, 2022 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the Borrowers, the Lenders party thereto and the Administrative Agent, (ii) Pledge and Security Agreement, dated as of April 28, 2022 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Borrowers and the Administrative Agent, and (iii) Trademark Security Agreement, dated as of April 28, 2022 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), made by the Borrowers in favor of the Administrative Agent, the Borrowers pledged and granted to the Administrative Agent a security interest in and continuing lien on all of the Borrowers' right, title and interest in, to and under the trademarks listed on Schedule 1 attached hereto (the "Trademark Collateral");

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by the Borrowers to the Administrative Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on May 17, 2022, at Reel 7711, and Frame 0490;

**WHEREAS**, the Administrative Agent has agreed to irrevocably and fully terminate, release and discharge its entire security interest and lien on all of the Trademark Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Administrative Agent hereby automatically, irrevocably and fully releases and discharges all of its mortgages, liens and security interests in all of the Borrowers' right, title and interest in, to and under the Trademark Collateral, which had been granted under the Trademark Security Agreement and hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Trademark Collateral to the Borrowers.

2. The Administrative Agent authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED IN ACCORDANCE


WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
