**TRADEMARK ASSIGNMENT AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Assignor hereby irrevocably assigns, conveys, transfers and delivers to Assignee, absolutely and forever, and Assignee hereby accepts, all of Assignor's entire right, title and interest in and to the Assigned **Trademarks**, together with all **common law** rights thereto and the goodwill of the Business symbolized by, appertaining thereto, and associated with the Assigned **Trademarks**, and a portion of the business associated with the marks of the Assigned **Trademarks**, as of the Effective Date.

This **Assignment** shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

This **Assignment** may be executed in one or more counterparts and delivered via facsimile, pdf, or other electronic means, each of which shall be deemed an original as against the party that signed it and all of which shall together constitute one and the same agreement, and shall become effective when one or more counterparts have been signed by each of the parties hereto and delivered to the other party, it being understood that both parties need not sign the same counterpart.
