Second Lien Release of Security Interest in Trademarks

This Second Lien Release of Security Interest in Trademarks, dated as of **November 2, 2023** (the “Release”), is made by UBS AG, STAMFORD BRANCH, as collateral agent (in such capacity, the “Agent”) in favor of **GUNNEBO INDUSTRIES, INC.**, an **Oklahoma corporation** (the “Grantor”).

WHEREAS, by (i) that certain Second Lien Security Agreement, dated as of December 10, 2019 in favor of Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related second lien Grant of Security Interest in Trademark Rights, dated as of December 10, 2019 in favor of Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 11, 2019 at Reel 6812 Frame 0944, the Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desire Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the Trademark Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.


The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
