TRADEMARK ASSIGNMENT

This assignment is being made in compliance with Section 10 of the Trademark Act, 15 U.S.C. Section 1060.

Assignor hereby authorizes and requests the Commissioner of Trademarks to record Assignee as the owner of the Trademark. Assignor further agrees to execute any additional documents as may be reasonably necessary or desirable to confirm the assignment of the Trademark to Assignee without charge, provided, however, that all additional costs of preparing and recording such additional documents shall be borne by Assignee.

Assignor represents and warrants that it is the exclusive owner of all right, title and interest in and to the Trademark, ~~is~~ liens, encumbrances, claims and assignments with respect to the Trademark, and has the authority to assign its rights to the Trademark to Assignee.
