**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the "Release"), dated as of September 12, 2023 (the "Release"), is made by **EAST WEST BANK**, as Bank (as defined in the Loan Agreement (as defined below)), in favor of **INSPIRATO, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS Bank and Grantor are parties to that certain Loan and Security Agreement dated October 15, 2020 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Loan Agreement").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 15, 2020 by and between Bank and Grantor (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), Grantor granted to Bank a security interest in all of Grantor's right, title, and interest in and to the Copyrights, Trademarks and Patents set forth on **Schedule A** attached hereto.

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on October 16, 2020 at Reel/Frame 7075/0446;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank, without representation, warranty, or recourse, hereby (i) terminates the Security Agreement, (ii) terminates, cancels, and releases its security interest in and to the Collateral granted pursuant to the Security Agreement, and (iii) reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the any of the Collateral (including, without limitation, the trademark(s) and/or trademark application(s) and patent(s) and/or patent application(s) identified on **Schedule A** attached hereto) and associated common law rights and goodwill appurtenant thereto. Bank hereby acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office, the United States Copyright Office or any other governmental office to evidence the release granted herein at the sole expense of the. Bank authorizes the Grantor or its designees (which may include their counsel) to record this Release with the United States Patent and Trademark Office, the United States Copyright Office and any other applicable registry at the sole expense of the Grantor and authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release. At the request and sole expense of the Grantor, the Bank agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.
