ASSIGNEE is a successor to ASSIGNOR'S business. Pursuant to 15 U.S.C. §1060(a)(1) and 37 C.F.R. §3.16, this Trademark Assignment includes a transfer of the entire business of the ASSIGNOR, or at least the portion of the business to which the Trademarks pertain, that business being ongoing and existing.
