**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Release”) is made as of November 8, 2023, by **KKR LOAN ADMINISTRATION SERVICES LLC**, a Delaware limited liability company, in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) in favor of **WELLTOK, INC.**, a Delaware corporation with an address at 3002 Brighton Boulevard, Unit 743, Denver, Colorado 80216 (the “Pledgor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, whether defined directly therein or by reference to another agreement.

W I T N E S S E T H:

WHEREAS, the Pledgor and the Collateral Agent are party to a First Lien Security Agreement, dated as of April 6, 2021 (as may have been amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Pledgor and the Collateral Agent entered into that certain First Lien Trademark Security Agreement, dated as of January 7, 2022 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on January 10, 2022 at Reel 7554, Frame 0955;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a first priority Lien (subject to Permitted Liens and the terms of the First Lien / Second Lien Intercreditor Agreement) on and security interest in (the “Security Interest”) all of its right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**; and

WHEREAS, the Collateral Agent has agreed to terminate and release the Security Interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, for itself and on behalf of the Secured Parties, hereby (i) terminates the Trademark Security Agreement, (ii) releases, terminates and discharges any and all of its Security Interest in the Trademark Collateral, and (iii) re-assigns, transfers and conveys to the Pledgor any right, title or interest it may have in the Trademark Collateral.

The Pledgor, and any successor to the Pledgor (including any person or entity hereafter holding any right, title or interest in, to or under the Trademark Collateral) is hereby authorized to record this Release with the USPTO at the Pledgor’s sole cost and expense.
