## IP ASSIGNMENT AGREEMENT

This IP Assignment Agreement (this “Assignment”) is made and entered into as of October 27, 2023 (the “Effective Date”), by and between Gemstone LLC, a Delaware limited liability company (the “Assignor”) and Southwire Company, LLC, a Delaware limited liability company (“Assignee”).

WHEREAS, Assignor owns all right, title, and interest in and to the intellectual property and technology assets listed on Schedule A hereto (collectively, the “Transferred Intellectual Property and Technology”).

WHEREAS, the parties hereto are entering into this Assignment in order for Assignor to contribute, convey, assign, transfer and deliver all of its right, title and interest in and to the Transferred Intellectual Property and Technology to Assignee.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby contributes, conveys, assigns, transfers and delivers to Assignee Assignor’s entire right, title and interest of every kind and character throughout the world (including, without limitation, all federal, foreign, statutory and common law and other rights therein) in and to the Transferred Intellectual Property and Technology and any foreign and international applications claiming priority to said assets, together with: (i) all goodwill associated therewith, (ii) the right to apply for and obtain registrations and renewals therefor, (iii) all income, royalties, damages, claims and payments now or hereafter due or payable under and with respect thereto, (iv) the right to bring any action, claim or proceeding and recover for the infringement, misappropriation, dilution or unauthorized use of any of the foregoing accruing or occurring at any time prior to, on or after the Effective Date and to retain all monies and proceeds therefrom, and (v) the right to assign the rights conveyed herein (collectively, the “**Assigned Rights**”). Assignee shall hold the Assigned Rights for its and its successors’ and assigns’ enjoyment, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

2. Acknowledgement. Assignee acknowledges and agrees that the Transferred Intellectual Property and Technology and the contribution, conveyance, assignment, transfer and delivery made hereunder are subject in all respects to (i) non-exclusive licenses granted in the ordinary course of business, (ii) that certain Patent Cross-License Agreement, dated as of October 19, 2018, by and between Honeywell International Inc. and Resideo Technologies, Inc., and (iii) that certain Intellectual Property Cross-License Agreement, dated as of October 26, 2018, by and between Honeywell International Inc. and Resideo Technologies, Inc.

3. Authorization. Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue Intellectual Property registrations, to record this Assignment, and to issue or transfer said Transferred Intellectual Property and Technology to the Assignee as owner of all right, title and

interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.




