**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this "Termination and Release") dated as of November 7, 2023, is made from FIRST-CITIZENS BANK & TRUST COMPANY (successor by merger to OneWest Bank, a division of CIT Bank, N.A. FKA OneWest Bank, F.S.B.), as administrative agent for the Lenders (in such capacity, the "Agent") to ADEN & ANAIS, INC., as successor by merger to Aden & Anais Merger Sub, Inc., a New York corporation (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined in the Security Agreement referenced below), the Security Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of January 6, 2012, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by the Grantor in favor of the Agent, the Grantor executed that certain Trademark Security Agreement, dated as of January 6, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 4693 Frame 0623, pursuant to which the Grantor granted a security interest to the Agent, for the benefit of the Lenders, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule I.

2. If and to the extent that Agent has acquired any right, title or interest in or to any of the Trademark Collateral, Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of Agent's right, title, and interest in and to the Trademark Collateral, along with any goodwill in the Trademarks that the Agent may have acquired.
