This Plan of Merger (this "Plan") is entered into by and among Center for Applications of Psychological Type, Inc. ("CAPT"), and Myers & Briggs Foundation, Inc., a Florida not-for-profit corporation ("MBF") on December 13, 2022. CAPT and MBF are hereinafter collectively called the "Merging Entities."

WITNESSETH:

Whereas, the Merging Entities desire to merge, following which MBF shall be the surviving entity (the "Merger");

Whereas, Section 617.1101 of the Florida Statutes permits the merger of the Merging Entities in the manner provided in this Plan; and

Whereas, the Board of Directors of CAPT and the Board of Directors of MBF deem the consummation of the Merger in the manner contemplated herein advisable, and accordingly have adopted and approved this Plan and have authorized the execution hereof by appropriate corporate action. There are no members of CAPT or MBF.

Now, therefore, for and in consideration of the promises and of the covenants and agreements hereinafter set forth, the parties hereto agree as follows:

1. *Merging Corporation.* The exact name, form/entity type and jurisdiction of the merging corporation is as follows:

3. *Terms and Conditions.* The terms and conditions of the Merger (in addition to those set forth elsewhere in this Plan) and the mode of carrying the same into effect are as follows:

3.1 Effective January 1, 2023, 12:00 a.m., and filing and approval of the Articles of Merger with the Florida Department of State (the "Effective Time"): (a) CAPT shall be merged with and into MBF and MBF shall be the surviving entity and shall have all the rights, privileges, immunities, and powers and shall be subject to all the duties and liabilities of a corporation under the Florida Statutes; (b) the separate existence of CAPT shall cease; (c) MBF shall thereupon and thereafter possess all the rights and privileges, immunities, and franchises, of a public as well as of a private nature, of CAPT; and all property, real, personal, and mixed, and all debts due on whatever account, including all choses in action, and all and every other interest, of or belonging to or due to CAPT shall be taken and deemed to be transferred to and vested in MBF without further act or deed; and (d) all corporate acts, plans, policies, contracts, approvals and authorizations of CAPT and its respective partners, officers and agents, that were valid and effective immediately prior to the Effective Time, shall be taken for all purposes as of the acts, plans, policies, contracts, approvals and authorizations of MBF and shall be as effective and binding thereon as the same were with respect to CAPT.

If at any time after the Effective Time MBF shall consider or be advised that any further deeds, assignments or assurances in law or in any other things necessary, desirable or proper to vest, perfect or confirm, of record or otherwise, in MBF, the title to any property or rights of CAPT acquired or to be acquired by reason of, or as a result of, the Merger, CAPT (or the proper officers and trustees of such) shall execute and deliver such proper deeds, assignments and assurances in law and do all things necessary, desirable or proper to vest, perfect or confirm title to such property or rights in the Surviving Entity and otherwise to carry out the purpose of this Plan.

4. *The Articles of Incorporation of MBF.* The Articles of Incorporation of MBF shall be amended and restated as of the Effective Time upon filing with the Secretary of State.

5. *Miscellaneous.*

5.1 Capitalized terms used and defined in this Plan shall have the meanings assigned to such terms.

5.2 For the convenience of the parties, any number of counterparts hereof may be executed and each such counterpart shall be deemed to be an original instrument.

5.3 This Plan shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
