## ASSIGNMENT OF TRADEMARK

WHEREAS, Mprezas, Inc., a corporation organized under the laws of California (“Mprezas”) is the owner of the DESINFLAMAX trademark (the “DESINFLAMAX Mark”) and owns or has applied for federal registrations of the DESINFLAMAX trademark (U.S. Reg. Nos. 6821155 and 7017041, and U.S. Serial No. 90896029) (the “DESINFLAMAX Registrations”).

WHEREAS, Mprezas has agreed to assign the DESINFLAMAX Mark and DESINFLAMAX Registrations to Belmora, LLC, a limited liability company organized under the laws of the Commonwealth of Virginia (“Belmora”) pursuant to the Confidential Settlement Agreement and Mutual Release, dated October 30, 2023.

Mprezas hereby unconditionally grants, assigns and pledges to Belmora, all of Mprezas’s right, title and interest in and to, whether now owned or hereafter acquired or arising, in the DESINFLAMAX Mark and DESINFLAMAX Registrations, including:

- a. all goodwill of the business connected with the use of, and symbolized by, the DESINFLAMAX Registrations and any trademark intellectual property license involving the DESINFLAMAX Mark or DESINFLAMAX Registrations; and
- b. all products and proceeds (as that term is defined in the Uniform Commercial Code) of the foregoing, including any claim by Mprezas against third parties for past, present or future (i) infringement or dilution of the DESINFLAMAX Mark exclusively licensed under any intellectual property license, including the right to receive any damages, (ii) injury to the goodwill associated with the DESINFLAMAX Mark, or (iii) right to receive license fees, royalties, or other compensation under any trademark intellectual property license.
