**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

WHEREAS, as of the Effective Date, Secured Party has released its liens on all of the Intellectual Property Collateral, including, without limitation, the Released IP Collateral.



1. Secured Party's security interest in the Intellectual Property Collateral, including the Released IP Collateral, was terminated and released.

To the extent Secured Party retains any interests whatsoever in the Intellectual Property Collateral, including the Released IP Collateral, Secured Party hereby assigns, transfers and conveys to Borrower, all of Secured Party's rights, title and interests, now owned or hereinafter acquired; that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interests and collateral assignment in the Intellectual Property Collateral, including the Released IP Collateral. Such assignment, transfer and conveyance by Secured Party is made without any representation or warranty, express or implied.
3. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Release.


