2. Assignor herein is permitted to use the Assigned Trademarks without any license fee after the completion of the assignment.
3. ALL WARRANTIES WITH RESPECT TO THE REGISTRABILITY OF THE Assigned Trademarks OR NON-INFRINGEMENT OF USING THE ASSIGNED TRADEMARKS, EXPRESS OR IMPLIED, ARE HEREBY DISCLAIMED AND EXCLUDED BY ASSIGNOR. ASSIGNOR WILL NOT, UNDER ANY CIRCUMSTANCES, BE LIABLE TO THE ASSIGNEE


OR ITS LICENSEES FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL, INCIDENTAL, SPECIAL, OR EXEMPLARY DAMAGES ARISING OUT OF OR RELATED TO USE OF OR INABILITY TO USE OF THE ASSIGNED TRADEMARKS, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR LOSS OF BUSINESS, EVEN IF THE IT IS APPRISED OF THE LIKELIHOOD OF SUCH DAMAGES OCCURRING.


4. **Governing law and Dispute Resolution**

This Agreement shall be expressly governed by the laws of the People's Republic of China without regard to conflict of laws principle. All disputes arising out of or relating to this letter shall be resolved by both parties through friendly negotiation. If the dispute has not been resolved within thirty (30) days after the written request for negotiation was sent, such dispute shall be submit to Shenzhen Longgang District People's Court. The Parties agree to submit the exclusive jurisdiction of, and agree that venue is proper in, these courts in any such action or proceeding.
